This is with reference to your online application executed on 25/06/2012, on the above subject

In this connection, I am directed to convey the sanction for extension of provisional affiliation of the school with the Board for its Secondary School Examination and Senior School Certificate Examination for a further period of Five year(s) w.e.f. 01.04.2013 to 31.03.2018 subject to the fulfillment of the following conditions:-

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.
2. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.
3. The School is required to apply on online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000 per month.(Amended Rule 15.11)
4. Provisional Affiliation granted to a school will remain valid on receipt of online application of a school for further extension of provisional affiliation subject to the final decision of the Board.(Amended Rule 15.11)
5. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under:
from Pre-Primary to Class XII :-

Other Conditions :

Conditions for which Compliance to be submitted with in three months from the date of issue of sanction letter :-

1. Running /Starting of class IX/X or XI/XII without prior Provisional Affiliation upto Secondary level /Sr. Secondary level from the Board would be unauthorised and school shall be responsible for the consequences arising out of it.
2. Non submission of application for extension of Provisional Affiliation by 30th June of the year preceding to the year by which provisional affiliation granted, expires, would also attract violation of provisions of Affiliation Bye Laws.
3. School will not prepare any student/start any class for any other Board except CBSE from their CBSE Affiliated school Building/premises.
4. The Board would not allow any transfer of property/sale of school by one Society /Management / Trust to another Society / Management / Trust through agreement /sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the board shall withdraw its affiliation with immediate effects.
5. Pay and allowances to staff should be revised from time to time to bring it at par with that to the State Government.
6. The service conditions be strictly followed as per State Education Act and staff be given appointment / Confirmation letters etc. accordingly.
7. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee. Of these 2-3 may be Principal of KV/JNV
8. The School shall maintain Section teacher Ratio at least 1:1:5 at each level i.e. primary (I-V) Secondary (VI-X) and Sr. secondary (XI-XII)
9. The school has to constitute a committee for protection of women from sexual harrasment at the work place and to abide by the guidelines and norms prescribed by the Hon'ble Supreme Court of India in W.P. Criminal No. 666-70 of 1992 Vishakha and others state of Rajasthan and others delivered on 13/08/1997.
10. Rs. on account of annual fee for..... years may please be remitted.
11. The school shall maintain Reserve Fund in the joint names of the Manager of the school concerned and the Secretary of the Board in the scheduled Bank to the extent indicated below :-

With reference to your application dated 28/06/2007 on the subject cited above, I am directed to convey for extension of provisional affiliation of the school with the Board for its **Secondary School Examination/ School Certificate Examination** for a period of **five year(s)** w.e.f **01.04.2008 to 31.03.2013**, in the subjects in which the School already stands affiliated. subject to fulfillment of the following conditions:-

1. The School is required to follow syllabi and courses as per scheme of studies prescribed by the Board for respective Examination.
2. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.
3. The School is required to apply for further extension of affiliation through On Line at CBSE www.cbseaff.nic.in along with the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires.
4. The School is required to remit Rs.2500/- as balance fee for considering extension for further 5 years in which the annual fee as the fee applicable for extension of Provisional Affiliation has been revised to Rs.12,500/- in which the Rs.10,000/- w.e.f. 1.4.2006.
5. There are no Parents Representatives and Teachers representatives in the School Managing Committee. The school is required to re-constitute the School Managing Committee as per provisions of Affiliation Bye-Laws of the Board and forward a panel of 5-6 Principals of Senior Secondary School affiliated with the Board (3 Principals from J.N.V. /K.V.) for approval of CBSE's nominees in the School Managing Committee as per Affiliation Bye-Laws of the Board.
6. The school is required to pay DA to the staff as per State Govt. norms.
7. Other conditions as per Annexure 'A' (enclosed).

(ii) Sr. Secondary School with two streams	3000 sq. mtrs	900 upto Class XII

7. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.
8. Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.
9. Other conditions are enclosed as per Annexure 'A'.
10. **Special conditions to be complied within three months:-**
 - i) The school is required to renew Certificates regarding availability of Fire Safety, Safe Drinking Water and Sanitary conditions, etc.
 - ii) The School Managing Committee has not been constituted as per Affiliation Bye-Laws, therefore, it may be reconstituted by including representatives of teachers, parents and CBSE.
 - iii) The School is not paying salary to the staff as per Affiliation Bye-laws. The staff be paid salary at least at par with the salary of corresponding category employees working in State Government schools.
 - iv) Efforts should be made by the school to increase the number of students in I-V and Senior Secondary classes.
