Conditions for which Compliance to be submitted with in three months from the date of issue of sanction letter:

- 1. Running /Starting of class IX/X or XI/XII without prior Provisional Affiliation upto Secondary level /Sr. Secondary level from the Board would be unauthorised and school shall be responsible for the consequences arising out of it.
